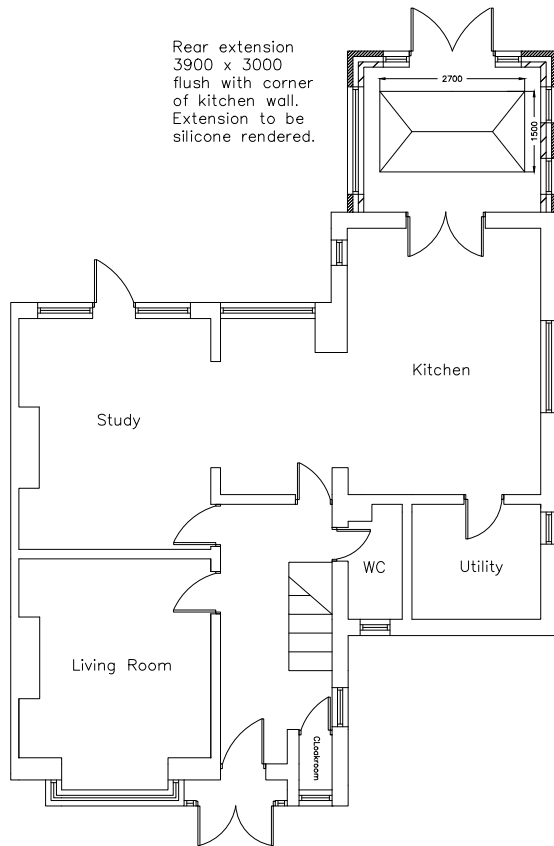

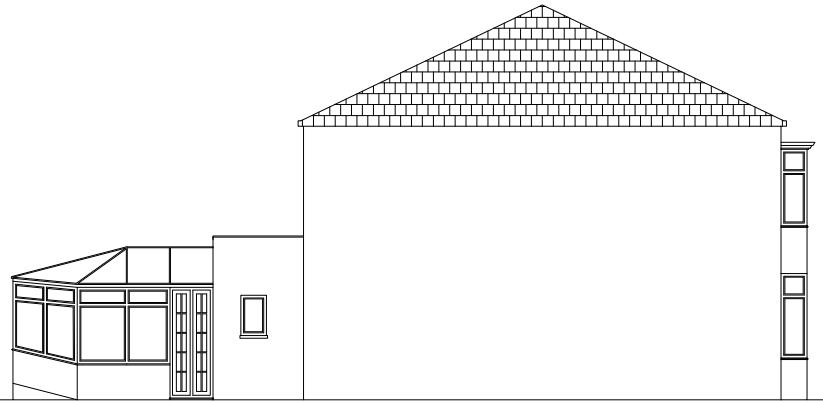

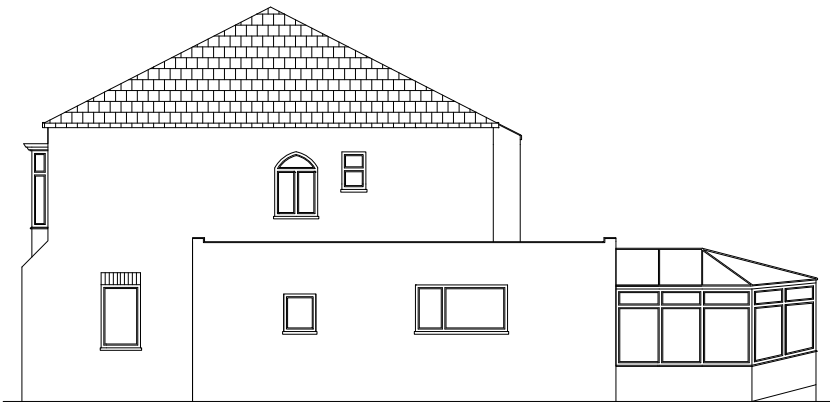

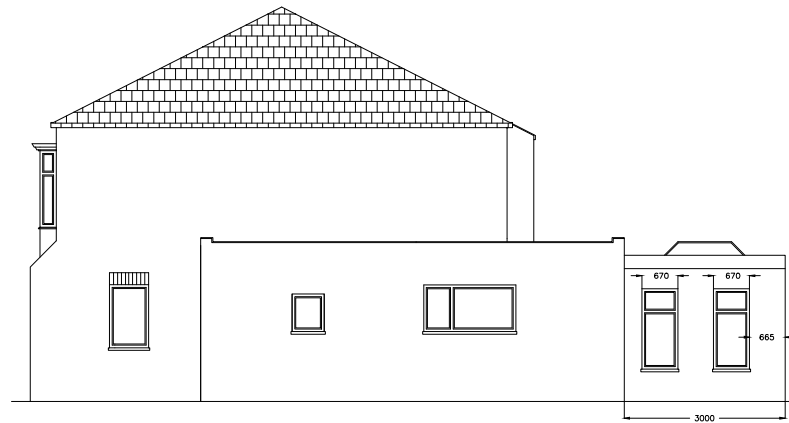
Existing Left H/S Elevation
